CARE NET OFFERS 22 MENTORING PROGRAMS FACILITATED BY VOLUNTEER MENTORS AND SUPERVISED BY STAFF IN THREE LOCATIONS IN NORTHERN KENTUCKY. THE MENTORING PROGRAMS ARE DESIGNED TO EDUCATE, SUPPORT AND ENCOURAGE MEN AND WOMEN IN HEALTH AND WELLBEING TO BETTER EQUIP THEM FOR THE ROLE OF PARENTING THEIR CHILD FROM CONCEPTION TO ADOLESCENCE. IN 2022, 2,718 EDUCATIONAL MENTORING SESSIONS WERE PROVIDED BY 42 MENTORS AND STAFF. CARE NET'S MENTORING PROGRAM IS AVAILABLE BOTH ONLINE AND IN PERSON INCREASING PARTICIPATION LEVELS. ALL PROGRAMS ARE INCENTIVIZED, DRIVING HIGH PARTICIPATION AND A 95% COMPLETION RATE. THE MENTORING PROGRAM IS A CRITICAL SERVICE TO OUR COMMUNITY AND ALLOWS CHRISTIAN VOLUNTEERS THE OPPORTUNITY TO INVEST IN THE LIVES OF THOSE NEEDING SUPPORT AND ENCOURAGEMENT WHEN FACING AN UNINTENDED PREGNANCY OR PARENTING CHALLENGES.

OF THE VIABLE ULTRASOUNDS 92% OF THOSE WOMEN CHOSE TO CARRY THEIR PREGNANCIES. THE MEDICAL DIRECTOR OF ULTRASOUND DONATES PROFESSIONAL SERVICES TO PROVIDE THIS NEEDED SERVICE TO THE COMMUNITY.
