CARE NET OFFERS 42 MENTORING PROGRAMS FACILITATED BY VOLUNTEER MENTORS AND SUPERVISED BY STAFF IN THREE LOCATIONS IN NORTHERN KENTUCKY. THE MENTORING PROGRAMS ARE DESIGNED TO EDUCATE, SUPPORT AND ENCOURAGE MEN AND WOMEN IN HEALTH AND WELLBEING TO BETTER EQUIP THEM FOR THE ROLE OF PARENTING THEIR CHILD FROM CONCEPTION TO ADOLESCENCE. IN 2025, 3,352 EDUCATIONAL MENTORING SESSIONS WERE PROVIDED BY 55 MENTORS AND STAFF. CARE NET'S MENTORING IS A HYBRID PROGRAM OFFERING BOTH IN PERSON AS WELL AS ONLINE MENTORING TO MEET CLIENT NEED AND INCREASE LEVELS. ALL PROGRAMS ARE INCENTIVIZED, DRIVING HIGH PARTICIPATION AND COMPLETION RATE. THE MENTORING PROGRAM IS A CRITICAL SERVICE TO OUR COMMUNITY AND ALLOWS CHRISTIAN VOLUNTEERS THE OPPORTUNITY TO INVEST IN THE LIVES OF THOSE NEEDING SUPPORT AND ENCOURAGEMENT WHEN FACING AN UNINTENDED PREGNANCY OR PARENTING CHALLENGES.
